The Permit is approved subject to the following conditions:

- 1. Existing Cabin shall be removed prior to the commencement of construction of the development outlined in this permit.
- 2. Applicant Shall comply with all property setbacks in accordance to the Land Use Bylaw.
- 3. The applicant shall obtain and adhere to the requirements where applicable, from the appropriate authority, permits relating to building, electricity, plumbing, sewer and drainage, and all other permits required in connection with the proposed development.
- 4. The property must be landscaped in such a manner to prevent surface drainage onto adjacent properties.
- 5. The applicant shall be financially responsible during construction for any damage by the applicant, his servants, his suppliers, agents or contractors, to any public or private property.
- 6. All municipal taxes and fees must be paid.

- 7. All improvements approved hereby must be completed within twenty four (24) months of the effective date of the permit.
- Development shall comply with recommendations of the Geotechnical report dated March 15th 2024.
- 9. Stormwater shall be directed to be maintained onsite or in accordance with any Water Act Approvals
- 10. The applicant shall display for no less than twenty-one (21) days after the permit is issued, in a conspicuous place on the site or on streets abutting the site, the enclosed notice.
- 11. No person shall keep or permit to be kept in any part of a yard any excavation, storage or piling of materials required during the construction stage unless all necessary safety measures are undertaken. The owner of such materials or excavation must assume full responsibility to ensure the situation does not prevail any longer than reasonably necessary to complete a particular stage of construction.
- 12. The total Height of the cabin shall not exceed 32' above grade upon completion.

This decision may be appealed to the Subdivision and Development Appeal Board within 21 days after the date on which a person qualified to appeal is notified of the decision.
